AGAIN:

INCENTIVE OF CONSTRUCTING 50 PERCENT OF NEXT YEARS LIST TO ACQUIRE WHATS OF GREATEST VALUE TO HIS SITUATION. IT SHOULD NOT BE AN ISSUE FOR THE STATE TO DISTRIBUTE ANOTHER SMALL PACKAGE AT THE 7/2 TO 8/2 MONTH POINT. CHUNKS OF RELIEF HERE. THERE TO ENSURE PRISONERS THAT BEING POSITIVE DOES INCREASE NOTICE. ITS MOST PREFERABLE, AS OPPOSED TO MAINTAINING THE STATUS QUO BOTH WAYS.

CURRENTLY

IF WE DID NOT ASSESS CORRUPT. MORALLY REPREHENSIBLE STATE OFFICIALS EATING UP THE 2.2 BILLION DOLLAR PER YEAR WELFARE CHECK WITH LEGAL, GROSSLY UNJUST ENFORCEMENT. ECONOMIC EXPLOITATION TO OUR DIRECT PERIL. DEHUMANIZING STATE OF Ongoing AFFAIRS, SUCH MEASURES WOULD

have been fully deployed decades ago. ....

AGAIN

IT WOULD MERELY COST 51.2 MILLION DOLLARS TO ACCEPT 40 THOUSAND PRISONERS A YEAR. A 1200 DOLLAR PACKAGE ONCE PER YEAR. N. NOT EVEN 100 MILLION DOLLARS TO ACCEPT A PACKAGE AT HALF CAPACITY. N. PRICE AT THE 7 1/2 OF 8 1/2 MONTH MARK. N. DELIVER ONE AT 77 PERCENT IN MED FEBRUARY. THEN, THEY SHOULD BE DISTRIBUTED AT 47 PERCENT CAPACITY EVERY 4 1/2 MONTHS AT UNPREDICTABLE TIMES.

I.E. → BY ALL OF THIS MATERIAL BEING PURCHASED IN BULK, N. BY IT BEING SO SUCH WAL-MART MEETS MENARDS OR WHOMEVER POSSESSES THE CONTRACT WILL SELL IT TO THE STATE AT HALF PRICE OR DISTRIBUTE MUCH MORE OF IT WHICH SHOULD BE DISTRIBUTED AT OTHER POINTS IN TIME.

AGAIN

INSTEAD OF PRISONERS BEING PAID OFFERINGS FOR EMPLOYMENT, MORE OF THESE MEASURES MUST BE DEPLOYED IN ALL ASPECTS. N. BECOME INSTITUTIONALIZED IN THE SOUL OF THE ~~THE~~ DEPARTMENT TO REPLACE ALL THE STAFF. CORRUPTION, DRUG ABUSE, SEXUAL ASSAULT. A GROSS LACK OF SUBSTANTIAL SOCIAL SERVICES, REHABILITATIVE OPPORTUNITIES, PROGRAMS, ASSISTANCE, BENEFITS, RESOURCES. N. TIME CUTS, BASED ON PARTICIPATION IN NEW INNOVATIVE GROUP THERAPY SESSIONS. N. SERVICES INTER-ALIA.
