This year comes closer to the possibility of my release from incarceration, and I'm seeking your sponsorship to help benefit my freedom to reunite with my family and be a productive member of society. It was unfortunate that my chances for parole were taken away by corrupt prison officials back on December 28th,2012, when I was falsely accused of assaulting (2) correctional officers. My litigation efforts through the courts of men have been unsuccessful, though I know that JAH(God) who is my higher power will bring me righteous judgement, reveal corruption and prove my innocence. On April 30th,2015, I was denied justice and freedom by the Board of Prison Hearings and given a (7) year parole denial at my initial parole consideration hearing at Kern Valley State Prison's "C" Facility. My next possibility to parole will be in 2022 when I am 42 years of age.

On February 09,2017, I was once again denied justice and freedom by the Los Angeles County Superior Court of California on a Habeas Corpus against the parole board's decision. Since 1993, before the age of 14 I have been the victim of violence, persecution, and corruption just because of my affiliations and my spiritual way of life. Until justice and freedom is brought to me, there will be no peace with corrupt officials and those who are on the side of the oppressors to keep me in prison.

My goal for the next (2) years is to raise a minimum of \$10,000 by 2022. This will go towards a private fund to help assist my new life upon release and a private attorney to represent me at my next parole hearing. The Garcia Family as well as myself believe we can meet this goal with the national and international communities help, and our strong faith in THE ALMIGHTY ELOHIM.

Any contributions from business owners, respected friends and citizens within the national and international communities would be a great blessing, and their generosity will definitely be repaid in the future when I am present. Only a small contribution of \$5 from 500 people will raise \$2,500 for one year!

Many of you have not personally met or know me, however my family and myself have been living in the city of Lancaster since 1973 and we have done many works to help the people of the Antelope Valley and beyond. It will be a blessing and a pleasure to meet, work, and fellowship with many of you. Your contributions will help earn a changed man his freedom, who has forsaken his old destructive path, loves and counsels others to what is good and righteous, and strives for peace. I seek to continue to do grassroots community work among the youth of different shades in the Lancaster/Palmdale area, throughout Los Angeles County and beyond, and give back to my community, instead of using violence as I once did in the past. Be on the lookout very soon for my first book: "Ras Oni's Book of Poetry & Wise Sayings" which will be distributed to the U.S. 'hoods & barrios to bring hope, light, and inspiration to the youth and their families.

My future project in the works is my autobiography;  
"Brim Respect: The Story of My Adolescence & the Bloods &  
Crips in the Antelope Valley". Stop the violence. Seek peace  
and a better way of life in our 'hoods & barrios. Fight against  
police corruption and the injustices within our courts and the  
government. Free all my O.G.'s and members from my Revolution:  
Big Kountry, Krazy Ray, Big Wrench, Lil' Deuce Fingers, and  
all the Six-Deuce Brims doing life in prison due to politics.  
Free all the B.L.O.O.D Line Souljahs and United B.L.o.O.D.  
Nation members doing life in prison due to poly-tricks.  
JAH is THE MOST HIGH judge and will use H.I.S. souljahs to  
fight against oppression and injustice. Your help will be a  
huge bless-in to my family, myself and especially my mother  
and son.
